ACCOUNTABILITY OBJECTIVE:

Services members by performing routine transactions; effectively educates both existing and potential members about credit union products and services; features and benefits and ensures that all necessary forms are properly completed for all services.

RESPONSIBILITIES:

- 1. Must be available to work within an assigned geographic region with occasional assignments outside of the region.
- 2. Thoroughly understand each service and benefit the credit union offers and how they interrelate into one financial package.
- 3. Educates members on the benefits and features of new, as well as, existing services. Ensures all supporting documentation is properly completed; inputs account information into system to establish service; performs general account maintenance as per member's request; forward all necessary documentation to Headquarters.
- 4. Receives member complaints and inquiries and initiates proper action, communicates resolution to member.
- 5. Process basic sales and service transactions, account maintenance, and all teller functions.
- 6. Balance cash and checks in cash drawer at the end of each shift.
- 7. Stays current with the usage of technology such as i-pads and smart phones, demonstrating their usage in mobile banking to members while migrating them to alternative delivery channels when appropriate.
- 8. Prevents controllable losses through strict compliance with all security and compliance policies and procedures including, but not limited to red flags, fraud alerts, Chex systems, audit control and any other loss prevention processes currently in place.
- 9. Remains active in credit union training programs. Complete the position's present curriculum as outlined by completing the following credit union annual required compliance training and the supplemental courses listed within the prescribed time. Follows policy and procedure daily to ensure compliant with current regulations.
- 10. Required to attend Bank Secrecy Act training annually
- 11. Complete all other task, assignments or functions as assigned and/or required.

QUALIFICATIONS:

Education/Experience:

A High School diploma or equivalent, with a good mathematical aptitude. Minimum of 1 year of branch or equivalent experience with a financial institution. Continuing education preferred.
