The credit union's field of membership now includes anyone who lives, works, worships, volunteers, or attends school in the Southeastern Pennsylvania counties of Bucks, Chester, Delaware, Montgomery, and Philadelphia.

As a credit union, TruMark Financial is not-for-profit and exists solely for the benefit of its members, who are the sole owners of the institution. After allowing for reserves and operating expenses, TruMark Financial returns profits to its members in the form of competitive rates, higher investment returns, and fewer fees while at the same time reinvesting its earnings to develop new products and services. All deposit accounts are insured to at least \$250,000 by the National Credit Union Share Insurance Fund of the National Credit Union Association, a U.S. government agency.

TruMark Financial's number one priority is the financial well-being of its members. All TruMark Financial employees are committed to the concept of member banking.

Community outreach

TruMark Financials' philanthropic efforts and social responsibility focus allow the credit union's employees and members to interact with one another to give back to the community. The credit union is best known for educational outreach through its Building Financial Futures initiative. In 2017, TruMark Financial provided \$60,500 to 11 schools for personal financial resources as well as \$11,600 in scholarship funds through the Financial Jeopardy event. Additionally, the credit union delivered 154 school financial literacy courses, reaching 4,548 students.

In 2017, TruMark Financial staged three Financial Reality Fairs at local high schools, introducing approximately 650 students to personal financial concepts. Recognizing that the need for financial education is not limited high schoolers, the credit union also participated in a Financial Reality fair for re-entrants from the Pennsylvania Department of Corrections systems. A Financial Reality Fair is an interactive financial simulation providing an opportunity for participants to experience the impact of some of life's financial decisions in a safe learning environment. Participants identify their career choice and starting salaries then complete a budget sheet requiring them to live within their monthly salary while paying for basics such as housing, utilities, transportation, clothing, and food. Additional expenditures such as entertainment and travel are factored in as well.

TruMark Financial employees are encouraged to volunteer and provide support in the local communities. On select Fridays, employees wishing to "dress down" in blue jeans pay \$5.00 to the charity selected for that particular week. In 2017, employee dress down days raised \$12,295 for 19 charities. Employees are also encouraged to volunteer in the community, receiving time off for volunteer hours. In 2017, employees volunteered 1,380 hours to 74 different community groups.

Efforts will be continued and expanded in 2018. In addition to doubling the number of Financial Reality fairs, the credit union has started community outreach efforts involving the membership in philanthropic efforts. In 2018, career workwear was gathered for three different charity organizations, dogfood has been amassed for five animal shelters, children's books have been accumulated for dispersion across the five-county Philadelphia area, employees have participated in a Random Acts of Kindness Day, children's winter outerwear has been collected, and food has been collected for Hunger Awareness month.

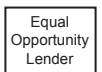
