3. I/we will resume making regular payments within two months if the loan is payable monthly or semimonthly or within 60 days if the loan is paid weekly or biweekly. All lines of credit are paid monthly. I am/we are aware the first and possibly second payment after the skipped payments may not reduce the principal balance.
4. Installment loans (if applicable): I am/we are aware that skipping these payments may extend the term of the loan by more than two months.
5. Equity loans/lines (if applicable): I/we certify that the secured property is owner-occupied and I/we have not received a condemnation notice.
